

How to Read the Traditional 21 Foot Court Schedules

- 1) Courts are numbered 1-16 and are identified at the top of each schedule
- 2) Game times are listed at the beginning of each row
- 3) Game numbers are listed under the column heading "Game"
- 4) Divisions are listed under the column heading "Div."
- 5) The teams playing in a particular game are listed under the column heading "Matchup"
- 6) Team names reflect the county program followed by the last names of both team members
- 7) The game number of your team's initial game will be used to determine where and when you play your second game
- 8) When you see Winner G1 v. Winner G2, this means the Winners of Game 1 and Game 2 will play each other in their second game
- 9) For example, Grant Co. Weaver-Shaffner plays in Game 1 on Court 1 at 9am
- 10) If they win, they play in Game 81 at 1:30pm on Court 1
- 11) If they lose, they play in Game 82 at 1:30pm on Court 2
- 12) There are two court schedules on each page because MOST divisions uses the same pair of courts for second games
- 13) For example, Division 210 has their first games on Courts 1 and 2
- 14) Depending on whether a team wins or loses, their second game will also be on either Court 1 or Court 2
