How to Read the 30 Foot (Unified and Traditional) Court Schedule

- 1) Courts are numbered 1-16 and are identified at the top of each schedule
- 2) Game times are listed at the beginning of each row
- 3) Game numbers are listed under the column heading "Game"
- 4) Divisions are listed under the column heading "Div."
- 5) The teams playing in a particular game are listed under the column heading "Matchup"
- 6) Team names reflect the county program followed by the last names of both team members
- 7) Game number of team's first game will be used to determine when and where second game is played
- 8) When you see Winner G1 v. Winner G2, this means the Winners of Game 1 and Game 2 will play each other in their second game
- 9) For example, Gibson Co. Greene-Mayer plays in Game 1 on Court 1 at 9am
- 10) If they win, they play in Game 98 at 2:05pm on Court 3
- 11) If they lose, they play in Game 99 at 2:05pm on Court 4
