- 5) For example, Dubois Co. #04 plays in Game 1 (G1) on Court 1 at 10am on Saturday.
- 6) If Dubois Co. #04 wins, they play in Game 33 on Court 1 at 1pm on Saturday.
- 7) If Dubois Co. #04 loses, they play in Game 34 on Court 2 at 1pm on Saturday.
- 8) Be sure to read the schedule and brackets carefully!
- 9) Most teams change courts for their second game depending on 1st game results.
