- 2) Game times are listed at the beginning of the rows.
- 3) The numbers under the heading "Div." are the division numbers.
- 4) The numbers under the heading "Game #" are the game numbers.
- 5) For example, Gibson Co. #01 plays in Game 67 (G67) on Court 1 at 10am on Sunday.
- 6) If Gibson Co. #01 wins, they play in Game 90 on Court 6 at 12pm on Sunday.
- 7) If Gibson Co. #01 loses, they play in Game 91 on Court 1 at 12:40pm on Sunday.
- 8) Be sure to read the schedule and brackets carefully!
- 9) Most teams change courts for their second game depending on 1st game results.
