- 5) If Tippecanoe Co. Ellrich-Hardnburg-Muthig-Onder wins, they play in Game 121 on Court 2 at 10:50am on Saturday.
- 6) If Tippecanoe Co. Ellrich-Hardnburg-Muthig-Onder loses, they play in Game 120 on Court 1 at 10:50am on Saturday.
